



# COOKIE POLICY

## 1. Introduction

Our website, <https://www.oceansfromspacevenice2020.org> (hereafter: "the website") uses cookies and other related technologies (for convenience all technologies are defined as "cookies"). Cookies are also placed by third parties that we have hired. In the document below we inform you about the use of cookies on our website.

## 2. What are cookies

Cookies are simple files sent together with the pages of this site and saved by your browser on the hard disk of your computer or other devices. The information collected in them can be sent back to our servers or to third-party servers during the next visit.

## 3. What are scripts?

A script is a piece of program code used to make your website work properly and interactively. This code is executed on our server or on your device.

## 4. What is a web beacon?

A web beacon (or pixel tag) is a small, invisible piece of text or image on a site that is used to monitor website traffic. To do this, various data about you is stored using web beacons.

## 5. Allow

When you visit the website for the first time, we will display a popup with an explanation of the cookies. As soon as you click on "All cookies", you give us permission to use all cookies and plugins as described in this declaration regarding popups and cookies. You can disable cookies through your browser, but take into account that your website may no longer function properly.

## 6. Cookie

### 6.1 Technical or functional cookies

Some cookies ensure the correct functioning of the site and that your user preferences remain valid. By placing functional cookies, we make it easier for you to visit our website. This way you don't have to repeatedly enter the same information when you visit our website, for example, the item stays in your cart until you have paid. We can place these cookies without your consent.

### 6.2 Analytical cookies

We do not use any analytical cookies on our website.

### 6.3 Advertising cookies

We do not use any advertising cookies on our website.

### 6.4 Social media buttons

We do not use social media buttons on our site to promote websites or share them on social networks.



## 7. Your rights with respect to personal data

You have the following rights relating to your personal data:

- You have the right to know when your personal data is needed, what happens to it, how long it will be kept.
- Right of access: you have the right to access your personal data of which we are aware.
- Right of rectification: you have the right to complete, correct, delete or block your personal data when you wish.
- If you give us consent to process your data, you have the right to withdraw this consent and to delete your personal data.
- Right to transfer your data: you have the right to request all your data from the controller and transfer all of them to another controller.
- Right to object: you have the right to object to the process of your data. We will respect this choice, unless there is a valid basis for the process.

To exercise these rights, do not hesitate to contact us. Please refer to the contact details at the bottom of this cookie statement. If you have a complaint about how we manage your data, we would like to hear from you, but you also have the right to lodge a complaint with the supervisory authority (the Data Protection Authority).

## 8. Enable / disable and cancellation of cookies

You can use your browser to automatically or manually delete cookies. It is also possible to specify that certain cookies cannot be placed. Another option is to change the settings of your internet browser in order to receive a message each time a cookie is placed. For more information on these options, see the instructions in the Help section of your browser.

Remember that our site may not work properly if all cookies are disabled. If you delete the cookies in your browser, they will be stored again after your permission when you visit our site again.
